College Policy Manual changes for April 1, 2022**P101: Corporate Health and Safety**

This policy underwent its annual review. No changes were made.

P103: Safe College Campus

This policy underwent its annual review. No changes were made.

P104: Sexual Violence and Sexual Assault

Amended (Feb. 23, 2022)
effective April 1, 2022

This policy underwent its annual review. Changes reflect language directed by the Ministry of Colleges and Universities (MCU) as a result of consultations which took place in August 2021. On September 16, 2021, MCU announced regulatory changes to support postsecondary students reporting sexual violence or harassment. As a result, O. Reg. 131/16 (Sexual Violence at Colleges and Universities), made under the Ministry of Training, Colleges and Universities Act was amended. Language in this policy was added in section 5/Reporting and Responding to Sexual Violence and section 6/Complaint Process and Investigation, to ensure complainants are not subject to unwarranted discipline or irrelevant questions during the reporting, complaint and investigation process. Our current practices are compliant with these changes.

P208: Respectful College Community and Prevention of Harassment and Discrimination

Amended (Feb. 23, 2022)
effective April 1, 2022

This policy was due for its annual review. Changes included an update to the frequency of mandatory training, and modifications under section 10.4 -Investigation, Report, Summary of Findings and Disposition. Other minor cosmetic changes were made.
