# College Policy Manual changes for January 26, 2023

### **TOR40 College Retention Working Group**

New (Jan. 26, 2023)

A new working group was established to evaluate academic tools to increase student retention after level 1.

# College Policy Manual changes for January 10, 2023

#### 1-F-02: Non-College Use of Resources

Rescinded (Dec 8, 2022)

This policy has been rescinded. Processes within this policy is now managed directly through the appropriate College department.

#### 1-F-07: Use of College Premises by Student Union

Rescinded (Dec 8, 2022)

This policy has been rescinded. Processes within this policy is now managed directly through the appropriate College department.

#### A103: Fanshawe College Credentials

Amended (Nov. 23, 2022/CC-22-03)

This policy has received updates to include microcredentials to the list of credentials that the College Offers. Additionally, the policy has updated the name of the Ministry, received formatting updates, and also limited structural updates to match the current policy manual.



# A118: Academic Off-Campus Experiential Learning

Amended (Nov. 23, 2022/CC-22-03)

This policy has received minimal updates to clarify the purpose statement and definitions. Additionally, the policy has updated the name of the Ministry, received formatting updates, and also limited structural updates to match the current policy manual.

# A122: Graduation from Approved College Programs

Amended (Nov. 23, 2022/CC-22-03)

This policy has been updated to strengthen the understanding that part-time post-secondary students are eligible for the Dean's Honour Roll and the President's Honour Roll. Additionally, the policy has updated the name of the Ministry, updated the degree nomenclature, received formatting updates, and also limited structural updates to match the current policy manual.

#### A138: Out of Country Travel

New (Nov. 16, 2022)

The purpose of this new policy is to establish a framework for assessing, approving and conducting voluntary program related international activities outside of Canada.

# A201: Scholarship Research and Creative Activity (formerly called Research and Innovation)

Amended (Jan. 4, 2023)

This policy received a full review. It was considered by academic administration and faculty knowledgeable on the subject matter. Major changes to this policy include:

- New title that reflects changes to the subject matter
- Enhanced focus on multiple types of research and creative activity
- Greater clarity for requirements for funded research vs non-funded research
- Greater clarity regarding differing roles of researchers at the College
- Enhanced standards for research involving human subjects or animals
- Addition of Research Data Management requirements
- Consolidation of multiple addenda into more relevant standards
- Removal of Study Guides addenda now managed by internal departments
- Removal of Intellectual Property addenda (moved to A205: Intellectual Property)
- Grammar and formatting changes
- Minimal changes occurred to addenda regarding Academic Freedom and Research Integrity Complaints



## **COLLEGE POLICY CHANGES**

# **A202: Library Learning Commons** (formerly called London Campus Library)

Amended (Jan. 4, 2023)

This policy was updated to reflect current practices and changes to governing legislation. The policy has been shortened to focus on principles of access and scholarly activities while directing patrons to the library website for routine procedures like service availability and operating hours.

# A204: Copyright

Amended (Jan. 4, 2023)

This policy was updated to reflect current practices and changes to governing legislation. The policy has been updated to comply with legislative changes in the Copyright Act and the College's compliance requirements.

#### **A205: Intellectual Property**

New (Dec. 8, 2022)

The purpose of this new policy is to clarify and describe the creation, ownership, and use of Intellectual Property at Fanshawe College.

#### A206: Commercialization

New (Dec. 8, 2022)

The College has developed this new policy in conformity with the requirements of the Commercialization Mandate Policy Framework, giving due consideration to the specificities of research in a college environment, the College's other policies relating to Intellectual Property and the current legislative framework. By adopting this policy, the College aims to foster an environment in which the commercialization potential for the Intellectual Property derived from Applied Research services rendered to Third-Party Entities can be maximized for the benefit of Ontarians.

# Schedule 1: Titles of Organizational Units (of STD03: Titles of Organizational Units and College Property)

Amended (Nov. 16, 2022)

Fanshawe International was renamed "International Strategy, Partnerships and Market Development" and the units that report to it were renamed as follows:

- International Enrolment and Business Process Solutions
- International Recruitment and Market Development
- International Student Engagement



### **TOR27: Program Advisory Committees**

Amended (Dec. 8, 2022)

Standard 1: School Guide for Program Advisory Committees of TOR27 has been updated to maintain currency with the Program Review Process and adjustments were incorporated related to the offering of microcredentials.

#### **TOR33: Accessibility Advisory Committee**

Amended (Dec. 7, 2022)

The EDI and Anti-Oppression Task Force includes a number of working groups to execute the goals and priorities identified by the Task Force. The Accessible Environments Working Group is one such group created under the Task Force. This will constitute an updated version of the AODA Steering Committee (TOR32). The Accessibility Advisory Committee (AAC) will now report into the Accessible Working Group as an advisory body to that newly constituted working group. The changes in the document reflect the transition of AODA work to the EDI portfolio and to the Task Force working group structure.

# TOR39: Strategic Enrolment Management (SEM) Plan Development Committee

New (Nov. 11, 2022)

A SEM Plan Development Committee has been created to develop a College SEM Plan.
