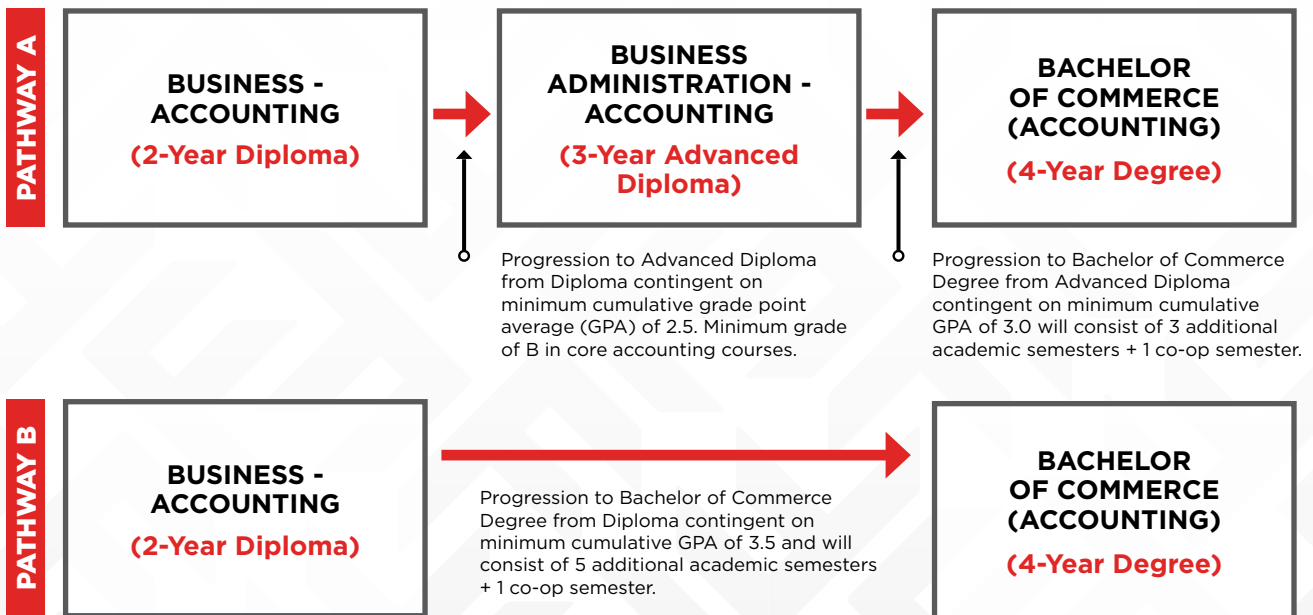
## Honours Bachelor of Commerce (Accounting) Degree

Students will study many aspects of accounting including financial accounting, cost accounting, management accounting, business finance, auditing and taxation in addition to a variety of general business management concepts including business strategy, marketing and human resources. The program will satisfy the degree requirements for all accounting professional bodies. This four-year, honours level degree includes a mandatory co-op work term between semesters 7 and 8.

Students will be well prepared to write the examinations for professional designations at the completion of the degree as well as fulfill experience requirements for these organizations after completion of the degree program. Graduates may work in positions such as an accountant, budget analyst, controller, financial analyst, taxation specialist, treasurer or auditor.

- ▶ Advanced Standing Entry — Semester 4 with a Fanshawe College Diploma (3.5 GPA) in Business–Accounting or Semester 6 with a Fanshawe College Advanced Diploma in Business Administration–Accounting (3.0 GPA)
