## **Program Description**

Fanshawe's one-year Advanced Law Enforcement graduate certificate program prepares students to pursue careers in a variety of law enforcement and security professions from private investigator and special constable to police investigator and border services officer.

Fanshawe is a leading law enforcement college in Ontario. This intensive program is completed in two 15-week semesters, each concluding with a five-week field placement that will immerse you in experiential learning opportunities with law enforcement, investigative and security agencies.

You'll broaden your knowledge and skill set to meet employer needs. The curriculum has been developed with input from experts in law enforcement, corrections, investigations and the Canadian Border Services Agency (CBSA) to address the current needs of the industry. The program ensures graduates meet physical fitness standards and use of defensive tactics, mental health awareness and care, crisis intervention and conflict management, record keeping and inter-professional communications and testifying in court.

- Sector-specific content includes regulatory enforcement, security for specialized environments and customs and border protection.
- You'll also receive instruction in investigative techniques including foot and vehicle surveillance and the use of surveillance technologies.
- The primary pathway to Advanced Law Enforcement, Investigations and Security is from the two-year Protection, Security and Investigation diploma program.
- Secondary pathways exist from the two-year Police Foundations diploma program and related programs (e.g., criminology degree from a university).

- Collect, preserve and record evidence, including digital evidence, in accordance with legislative requirements and recognized protocols.
- Assess situations to anticipate, mitigate and manage security issues.
- Administer and enforce laws, bylaws and regulations by investigating and resolving complaints, promoting compliance, and issuing infraction notices.
- Use appropriate problem-solving skills, non-violent intervention techniques, and other intervention strategies to effectively manage and resolve conflict and crisis situations.
- Employ appropriate intervention strategies to manage mental health situations to ensure the safety and security of all stakeholders.

# **Career Opportunities**

Graduates of Fanshawe's Advanced Law Enforcement, Investigations and Security program develop the specialized knowledge, skills and abilities for a variety of law enforcement and security fields, including:

- Municipal bylaw enforcement (bylaw enforcement officer);
- Provincial enforcement (peace officer, environment officer, conservation officer, forestry officer, alcohol and gaming inspector);
- Private investigation (private investigator);
- Site security (e.g., security guard, security officer, special constable in hospitals, courthouses, transportation and logistics, post-secondary institutions, airports or special events);
- Retail security (e.g., loss prevention officer);
- Cash services (e.g., armoured security);
- Canadian Border Services Agency (e.g., border services officer);
- National security and intelligence (e.g., intelligence officer, surveillance); and
- Corrections (e.g., correctional officer).

# Admission Requirements ONE OF:



- Protection, Security and Investigation Ontario College Diploma
- Police Foundations Ontario College Diploma
- A Degree in a related discipline (as determined by the College) upon completion of bridging program offered at Fanshawe College
- An equivalent qualification from another institution as judged by the College
- Acceptable combination of related work experience and post-secondary education as judged by the College\*

#### AND:

Proof of having achieved level 4.5 on the Leger 20-meter Shuttle Run Test

#### AND:

Pass a pre-screening that determines eligibility for field placement\*\*

#### Notes:

- \* Applicants may be required to submit a resume and cover letter that includes details of work experience.
- \*\* Applicants are advised that an individual's driving history, illicit drug use, criminal convictions, criminal associations and other personal behaviours may result in an applicant being ineligible for placement and therefore will not be eligible to graduate from the Advanced Law Enforcement, Investigations and Security program.

#### **Applicant Selection Criteria**

Where the number of eligible applicants exceeds the available spaces in the program, the Applicant Selection Criteria will be:

- Preference for Permanent Residents of Ontario
- Receipt of Application by February 1st (After this date, Fanshawe College will consider applicants on a first-come, first-served basis until the program is full)
- Achievement in the Admission Requirements



# **English Language Requirements**

Applicants whose first language is not English will be required to demonstrate proficiency in English by one of the following methods:

- TOEFL iBT: Score of 88
- IELTS Academic: Overall score of 6.5 with no score less than 6.0 in any of the four bands
- CAE: Overall score of 70 with no score less than 60 in any of the four bands
- PTE Academic: Score of 59
- Cambridge English: Overall score of 176 with no language skill less than 169
- ESL4/GAP5: Minimum grade of 80% in Level 9, 75% in Level 10
- Duolingo: Overall score of 120, with no score lower than 105

# **Recommended Personal Preparation**

Students of the Advanced Law Enforcement, Investigations & Security program will participate in physical fitness and defensive tactics courses each. Potential students should be physically active and familiar with the physical fitness requirements to work in the field of Law Enforcement. Students should be able to achieve level 3.0 on the Leger 20-meter Shuttle Run as a minimum prior to entry into the program.

# **Post-Admission Requirements**

Applicants are advised that driving history, illicit drug use, criminal convictions, criminal associations and other personal behaviours may result in an applicant being ineligible for placement and therefore ineligible to graduate from Advanced Law Enforcement, Investigations and Security. The following items are applicable to the program and are time sensitive:

- Possession of a Standard First Aid course certificate (either St. John Ambulance or Canadian Red Cross or equivalent) and a Basic Rescuer course certificate (Level 'C' CPR) and Automated External Defibrillator (AED)
- Possession of a valid class 'G' driver's licence and a driver's abstract that validates that the applicant has no more than 6 demerit points at program start
- Proof of Immunization Students cannot proceed to some field placement opportunities without proof of immunization
- Completion of Introduction to Incident Management System IMS 100 (Emergency Management Ontario)
- Security Guard License (issued by Ministry of Community Safety and Correctional Services)
- Clear (no criminal offences) Police Check for Vulnerable Sector Screening (VSS) completed within six months prior to application
- An interview will be conducted to determine eligibility for field placement
