## How to apply for Conditional Acceptance

To apply to Brescia University College at The University of Western Ontario for conditional acceptance, you must complete this application and submit it to Fanshawe College. Please note that in order to be accepted, you must submit specific original documents along with your application, as listed below in Part 5.

Upon acceptance, you will receive two letters of admission: one from Fanshawe College for ESL and one from Brescia University College for the degree you wish to pursue.

To qualify for entry to Brescia, you must meet the specific academic requirements for the degree program and must complete ESL Level 5 at Fanshawe with an 80% average. Provided you complete Level 5 with this average, you will not have to submit a TOEFL or IELTS score in order to gain entrance to Brescia.
