

The Fanshawe College International Learning Opportunity Scholarship provides eligible students with financial support to complete a portion of their academic or experiential learning abroad. Students completing an approved academic exchange, field study, or field placement, or co-op placement may apply.

Requirements:

- Must be a full-time, registered student during the period abroad (accessed for one term- 4 month per application).
- Must be in good academic standing (defined as a minimum **2.0 GPA** for all certificate, diploma, and advanced diploma programs and a minimum **2.5 GPA** for all collaborative, degree, and post-graduate programs).
- Must be participating in an approved academic opportunity.
- Open to Canadian and International students (provided they are not returning to their country of nationality) and meeting the above requirements.

Funding Amounts:

Program Duration	Funding Amount
1 – 28 Days	\$800.00 CAD
29 – 60 Days	\$1250.00CAD
61 – 120 Days	\$2500.00 CAD
121 Days or more	\$3,750.00 CAD (Co-op experiences only)

Please Note:

- The lifetime maximum for funding is \$3,750.00 CAD per student.
- If for any reason the participant does not attend the opportunity abroad or it ends early, it is expected that the funds will be returned to Fanshawe College.
- Total funding is limited per fiscal year. Funding is distributed on a first come, first served basis to those who are eligible.
- Eligible opportunities within the United States are only approved co-op or workplace experiential learning opportunities, not academic or cultural programs.
